Innovation

- ⌘ The digital or technological transformation serving the customer experience;
- ⌘ R&D policy for growth;
- ⌘ Innovation for women, or by women;
- ⌘ The development of an innovative product with successful marketing / international market-making thanks to the collaboration with start-ups.

Sustainable Operations

- ⌘ Operational excellence must not be embellished with structuring and ambitious objectives in terms of respect for the environment and sustainability;
- ⌘ Quality of customers/ suppliers relationships;
- ⌘ Improvement of the purchasing process;
- ⌘ Optimizing expenses to create value in the company.

HR 4.0

- ⌘ The existence of a qualitative element on the following themes: job creation, HR innovation or an HR transformation process;
- ⌘ Social inclusion;

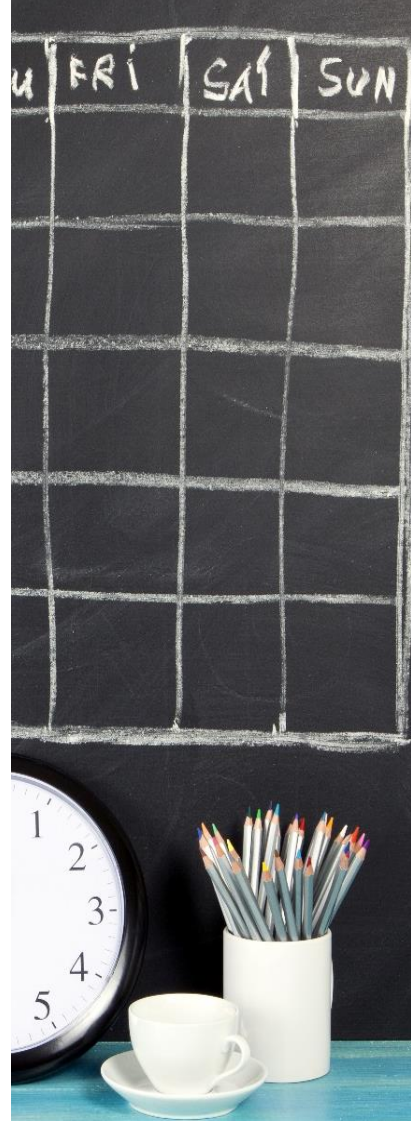
